# **New and ongoing Business**

- 1. Procedure and process for the upcoming election will follow the existing Charter, adding residents where appropriate.
  - a. Voter lists will include taxpayers, registered with and provided by the Town of Narragansett "*By-Laws Article 1 Section 5*"
  - b. Residents registered with the Narragansett Board of Canvassers, provided by the Narragansett Board of Canvassers "Judge Taft-Carter order"

- c. Residents eligible to vote, who are not registered with the Board of Canvas but have submitted their certification form to BSFD (By July 27, 2024), into locked drobox at BSFD Community Center 130 Bonnet Shore Rd. "Consent Judgement 1"
- d. Firms, Corporations and Unincorporated Associations, such as Partnerships & LLC's will designate its duly authorized person for voting, by submitting a notarized form provided by the BSFD and is only allowed one (1) vote. The form will be given to the Clerk of the District the day of voting to receive a ballot. "Charter Section 2 Page 3"
- e. Trustees will be included under the Taxpayer List as noted on the Narragansett Tax list. *Procedure*
- f. Tax Assessors will review the Town of Narraganset taxpayer list, Board of Canvassers resident list and BSFD Certified residents list. "*By-Laws Article 1 Section 6*"
- g. Tax collector will obtain a complete electronic district taxpayers list from the Town of Narragansett, and complete electronic district list of Resident voters from Narragansett Board of Canvasses and a list of district residents by street also by Board of Canvasses. "By-Laws Article 1 Section 6"
- h. Clerk/Tax collector will compile certified residents list from locked box and reviewed by tax assessors. Store in locked file cabinet "Consent Judgement 1"
- i. Mail, Email, Signage, Postings, Website, Lock box, all means of communication will all be utilized immediately.
- j. Letters, affidavits, certifications Motion-discuss-Vote
- k. Location of Annual meeting Motion-discuss-Vote
