During that meeting it was communicated by the Bonnet Shores Beach Club Committee Representative that there were 1847 BSBC eligible voters rather than the 2007 previously communicated. This presentation has been revised to reflect that new information.

Approach

Data can be evaluated through many different lenses

The approach in this analysis was to evaluate the potential dilution and the impacts of disenfranchising various voter affiliations.

A person could have multiple affiliations with our community but can only vote once. Therefore, the removal of one affiliation does not mean that voter is removed.

- Four Data Sources Used:
 - 1) Aug '24 Certified BSFD Property Tax List
 - 2) Aug '24 Certified Narragansett Voter Registration List
 - 3) Aug '24 Election Voter Registrations
 - 4) Dec '24 Town of Narragansett BSFD Rental Registrations
- Cross referenced individual names with property ownership and Narragansett Voter list to come up with 7 different affiliation combinations. Identified unique voters across the affiliations.
- Cross referenced to the Aug '24 Election Registration Sheets

(ex: 160 Col John Gardner and 22 Namcook are listed as rentals + 14 addresses on the Narr Voter Reg List that have no record on the BSFD Tax Roll)

Based on the August 2024 election, 22% of the 3560 potential voters turned out to vote (774 persons)

Observations:

- 1) BSFD affiliations have the majority in the current state
- 2) 460 net new voters were made eligible to vote due to consent order judgement. 46 turned out to vote (10%, representing 6% of total voter turnout)
- 3) Multiple affiliations with BSFD 58% of the total current eligible population has an affiliation with BSFD other than being a BSBC owner. Of this population 15% voted in the last election representing 68% of the registered voters (majority).
- 4) BSBC Only 42% of the total current eligible population is only a BSBC owner. Of this population, 7% voted in the last election representing 32% of the registered voters (minority – no dilution from BSBC ONLY)
- Potential litigation costs regarding the Constitutional alignment and Commercially zoned position held by some
- 6) Preserves +90 year relationship with BSBC

Observations:

- 1) Eliminates **73% (2579) of current eligible voters** (59% of the voters in the last election): **42%** would come from BSFD Affiliations and **58%** from BSBC Only Affiliation:
- a) **1092** Voters from the current BSFD Affiliated Populations (53% of Total eligible in the BSFD affiliation group and 27% of voters in the last election) representing BSFD Taxpayers with substantial interest:
 - Seasonal properties (~400/37% of the 1076 properties)
 - Rental properties (245/20% of the 1076 BSFD properties)
- b) 1487 Of the 1847 Potential Total BSBC Voters (81% of the Total eligible and 7% of voters in the last election).
- 2) Concentrates voting rights to a smaller population
- 3) Potential financial and quality of life implications with this scenario: Beach Maintenance, loss of Tax Revenue (annual and special assessments), potential litigation costs from disenfranchised constituents
- 4) Supports strong positions within the community that this is the only option citing Constitutional alignment for general municipalities that are governed by the board of elections (BSFD is not governed by the BOE).

Based on the August 2024 election, an estimated 34% of the 951 would turnout to vote (320 persons)

Observations:

- 1) BSFD would have the majority in this scenario
- 2) Provides 100% BSFD with substantial interest (home/land owners)
- 3) Eliminates 1077 voters (54%)
- 4) There are 695 BSBC units whose owners have no other affiliation with the BSFD which would represent 25% of the voting population in this scenario. Of that 691, 143 units voted in the last election representing 21% of the eligible units (minority no dilution from BSBC).*
- Preserves +90 year relationship with BSBC

Based on the August 2024 election, an estimated 24% of the 2738 would turnout to vote (670 persons)

^{*}BSBC has 930 Total Units. 152 Units voted in August yielding 263 Votes. 691 of those units are aligned to the "BSBC ONLY" affiliation of which 143 units voted yielding 243 votes.

- Provides 100% BSFD with substantial interest (home/land owners)
- 3) Of the 1847 Potential Total BSBC Voters, this scenario eliminates 1487 (81% of the potential). Only 247 Voted in the last election 7%).
- 4) Potential financial and quality of life implications with this scenario: Beach Maintenance etc.
- 5) Potential litigation from disenfranchised affiliation.

Based on the August 2024 election, an estimated 26% of the 1999 would turnout to vote (520 persons)

- 2) Over the course of 10 years the "makeup contribution" of BSFD Taxpayers will be \$732k assuming a maximum mil rate increase of 4% YOY to cover BSFD expenses
- 3) Removes BSBC contribution to any future Tax Assessments needed for major occurrences to be funded by Taxpayers
