BONNET SHORES FIRE DISTRICT 2025 Annual Meeting "DRAFT" Meeting Minutes Saturday August 2, 2025

- **1. Call to Order by District Moderator**-District Moderator Joe Thomas called the meeting to order at 10:10 am.
 - A. Pledge of Allegiance- District Moderator Joe Thomas led the assembly in the Pledge of Allegiance
 - B. Reflection on Deceased Members of the Fire District-District Moderator Joe Thomas took a moment of silence to reflect on deceased members of the district.
- 2. Proper notice and Quorum attested to by the Clerk-Clerk Pro Temp Janice McClanaghan stated that all public notices sent to the Providence Journal and Narragansett Times were posted on 7/18/25 and 7/25/25 and attested that we had a quorum.

Moderator Joe Thomas welcomed everyone and announced he will be following Robert's Rule and outlined the format of the meeting. Reminded everyone not to fill out your ballots, wait for nominations from the floor. There are (3) classifications for candidates: endorsed by Nominating committee, Registered candidates, who were not endorsed, and nominations from the floor.

There was a 'Meet the Candidates" forum that occurred to allow candidates to present their platform prior to the meeting to shorten the annual meeting agenda.

3. Report on Nominating Committee:

Moderator Joe Thomas announces especially for "write-ins" **put a checkmark** in right hand column for your vote.

- 6. Report of the Tax Collector: Laurie McCarthy gives Tax Collector report, states J. Chereskin, who was presently out-of-town, was appointed when Helen Patience resigned. 97% of taxes were paid in 2025, and 78% in the previous year. (Payments were made by check, online, E-check all found on BSFD website)
- 7. Report of the Treasurer- Laurie McCarthy

Laurie McCarthy highlighted the discussion regarding the 2 operating budgets and a cap on spending. The two operating budgets were for storms and legal.

- 8. Vote to Approve BSFD Land Trust Allocation for \$1500. Pursuant to Section 4 of the BSFD Land Trust Charter-Approved
- 9. Vote to Approve rates of Compensation for the following elected officials: Tax collector, clerk, and treasurer, pursuant to the BSFD by -laws. -Approved
 10.Ratification of 2024 Annual Meeting Minutes-Approved
- 11. Old Business-none
- 12. New Business:

Only two(2) minutes to speak, NO disparaging remarks a.*C Fortin- we should be using machines for voting.

Joe comments this will be brought to council who will make that decision.

13. Review and Explanation of Fiscal Responsibility By-Law changes:

a.*Patrick Kelly-questions about item 2a software upgrade.

Faith Lasalle stated a major upgrade to software was done due to the new computer system to simplify it.

Does District Manager have a capital expense fund? Faith stated it was \$35,000 for the upgrade.

Laurie McCarthy explains the need for monies related to fiscal responsibility and insurance coverage.

- b.*Sharon Doherty asks why we need a specific requirement to allocate dollars? Explanation is due to storm infrastructure, and extraordinary cap purchases totaling \$35,000 to \$60,000 due to storms/extreme weather.
- c. C. DeLeo addressed Grants. Grants are usually allocated in the Fall. Her concern is timing of approval needed for these Federal/State grants.
- d.*Faith LaSalle explains why the council is looking to have 'Caps" on spending. She states 'what we don't want is the Council to have a greater voice. Seven (7) people shouldn't be allowed to spend your tax dollars...
- e.*Bob Patterson; objects to Faith statement, "I am going to object to this. This is not the time to make arguments. This should have been done during the council meetings, which the public was invited to...not the day of the election."
- f.*A. Langer -comments on BSFD LT Charter/RI State. She stated that she was responsible for having the land in perpetuity. Most of these charter and bylaws changes are in conflict and shouldn't be discussed at an annual meeting.

- g.*Paula Childs-This is a change in our bylaws- important details should be addressed in public meetings and community input.
- h.*Lesle McKnight-stated there are lots of comments on social media. Don't criticize when people are trying to make things better for ALL in the community.
- i.*Paul Luba- his comment refers to the levy cap on spending. The council should not have Carte Blanche.
- j.*DeLeo- no fiscal responsibility was addressed until June 2025, need better input from the community
- F. Lasalle-responded that nothing has been done since June, 2023. She explained she and Leslie ran on fiscal responsibility so 7 people cannot spend their money. A Committee can make suggestions, but the council decides.

- 9. REGISTERED VOTERS OF NARRAGANSETT AND BSFD DEEDED OWNERS ONLY! NO VOTE FOR BSBC OWNERS, THEY DO NOT LIVE HERE.
- 10. I WOULD PREFER A 3RD OPTION. FULL TIME AND SEASONAL RESIDENTS HAVE A VOTE. BSBC ONLY PROPERTY OWNERS DO NOT HAVE A VOTE.
- 11.I SUPPORT ONLY POINTS 1 AND 2 OF OPTION #2. I DO NOT DEEMM BSBC CABANA OWNERS AS CONTRIBUTING TO THE OVERALL BETTERMENT OF THE BONNET SHORES COMMUNITY.
- 12.I THINK IT SHOULD BE NARRAGNSETT RESIDENT AND ANY OWNER OF RESIDENCE THAT INCLUDES AT LEAST ONE BEDROOM AND ONE BATHROOM WITHIN PROPERTY. 1 VOTER IS EQUAL PER RESIDENCE IF MORE THAN 1 OWNER-EACH VOTER IS EQUAL SHARE TO PROPERTY. 2 OWNERS EACH GET 50% VOTE.

VOTERS= BSFD RESIDENTS, PART-TIE OR FULL TIME. QWNERSHIP SHOULD NOT BE REQUIRED TO VOTE. BSBC OWNERSHIP OR MEMBERSHIP SHOULD NOT ENTITLE VOTING

- 14. TOO MANY UNANSWERED QUESTIONS.15 NOT BROKE.NO NEED TO FIX IT. NO CHANGE-STATUS QUO
- 15. THE ONLY FAIR WAY IS HOMEOWNERS ALONE SHOULD BE ALLOWED TO VOTE AS EVIDENT IN VOTING ACROSS THE STATE AND COUNTRY.
- 16. I WOULD ADVOCATE FOR A HYBRID OPTION, WITH ELEIGIBLE VOTS TO INCUDE:1 ANYONE LIVING IN THE BONNET REGISTERED TO VOTE IN NARRAGANSETT

- 26. RESIDENTS THAT OWN A "SUBSTANTIAL PROPERTY" WITHIN THE DISTRICT SHOULD BE ALLOWED TO VOTE.
- 27.REMAIN AS IS RIGHT NOW UNTIL WE ARE ABLE TO ARRIVE A SETTLEMENT WITH BSBC TO PROVIDE EQUITY AND ELIMINATE MULTIPLE VOTES PER "CLOSETS"
- 28.REDISTRICT SO BSBC IS NOT PART, SO WE CAN TRULY HAVE AGOOD RELATIONSHIP.
- 29. EVERYONE SHOULD HAVE THE RIGHT TO VOTE
- 30. SEVERE THE BSBC-MAYBE WE'LL GET ALONG
- 31. I DO NOT SUPPORT EITHER ABOVE OPTIONS-RESIDENTS WHETHER FULL OR PART TIME SHOULD HAVE VOTING RIGHTS BUT BSBC OWNERS (WITH ONLY 3 MONTHS A YEAR AVAILABILTY SHOULD NOT.

- 33. BEACH CLUB SHOULD HAVE SOME REPRESENTATION BUT NOT AS MUCH AS THEY HAVE CURRENTLY.
- 34. IT SHOULD REQUIRE PROPERT OWNERS IN THE DISTRICT WHOSE PROPERTY HAVE BEDROOMS AND BATHROOMS FOR VOTING. PERHAPS CLUB MEMBERS CAN HAVE AN ADVISORY BOARD TO MAKE RECOMMENDATIONS TO COUNCIL.
- 35. THEY ALL PAY TAXES AND SHOULD HAVE INPUT ESPECIALY SUMMER RESIDENTS.
- 36.I DO NOT SUPPORT EITHER. LET ALL VOTE.
- 37. THINK IT SHOULD BE ONLY BOTH OF 32. YOU SHOULD OWN PROPERTY AND BE REGISTERED TO VOTE SINCE THIS IS A FIRE DISTRICT. BEACH CLUB IS NOT REISDENTIAL.IF I HAVE A LOCKER AT A GYM, CAN I VOTE IN THAT TOWN.
