#### **Bio:**

- Homeowner and summertime resident of Bonnet since 2016
- Became a full-time resident in July 2025 after completing a full home rebuild
- Active in the BSFD Council for the past several years. Ran for BSFD Council in 2024. Received 296 votes (8th place in a vote for 7 positions).
- Active participant in the 2025 BSFD Charter Commission Committee. Developed and submitted a collaborative proposal that included input from both residents and BSBC representatives. Proposal was selected by the committee as a finalist option.
- Retired from 36-year career in High Tech in April 2024. In the final 15 years I served
  as a Global VP of Operations at SAP (a 110,000-employee company operating in 185
  countries). The role required skills aligned to ones needed in the BSFD council role –
  strategic planning, operational deployment, collaboration with people of diverse
  views, and clear transparent communication.
- Ran numerous complex multi-million-dollar organizational programs at SAP including collaboratively building out and deploying the global franchise operating model that is still in use today. The SAP franchise model is a global charter and operating plan for the company.
- Served as head of my prior community's homeowners association (in Sudbury MA) for 20 years (2003 to 2023)

#### What I would do if elected to the council:

- 1. Continue to collaborate with the council and community on a solution for updating the BSFD charter.
- 2. Champion building out a pragmatic, fiscally responsible, and transparent strategic plan that clearly defines the council's and communities' priorities. One plan defines what the council focuses its tight resources on time and money. The plan will be validated with the community and refined over time. It will be reviewed regularly in council meetings to ensure council e orts stay focused on accomplishing the priorities. Smaller issues will be handled in committee e orts. In my years of working with the council, I've seen significant council e orts and spending applied to "issues of the day" but no clear definition of what priority items must get done.
- 3. Champion enhanced communications, including regularly reporting on progress against a BSFD strategic plan. Work on finding ways to collect constructive input and feedback for continuous improvement of both plans and operations.
