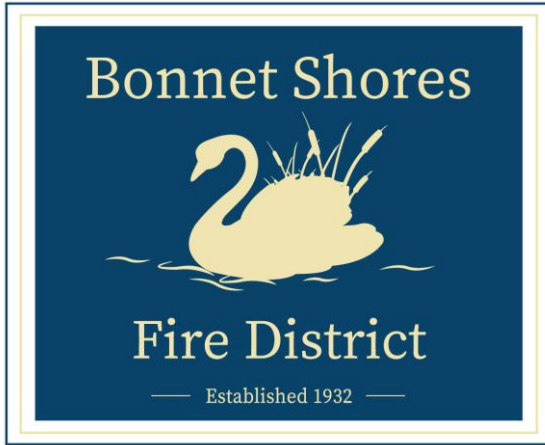




2026 Election Data Analysis

JUNE 25, 2026



Approach

Data can be evaluated through many different lenses

A person could meet multiple eligibility criteria but can only vote once. Therefore, the removal of one criteria does not mean that voter is removed.

- Four Data Sources Used:
 - 1) July '25 Certified BSFD Property Tax List (re-certified in June 2026)
 - 2) May '26 Certified Narragansett Voter Registration List
 - 3) June '26 Election Voter Registrations
 - 4) Dec '24 Town of Narragansett BSFD Rental Registrations (Town publishes a list annually in Dec)

Note: As with the 2024 and 2025 analysis, voted ballots were not used by the preparer for this analysis.
- Cross referenced individual names with property ownership and Narragansett Voter list to come up with 7 different eligibility combinations. Identified unique voters across the eligibility groups.
- Cross referenced to the June '26 Election Registration Sheets

The above is a hierarchy of possible voter registrations as follows:

1. If you are a Narragansett Registered Voter, you appear in the Narragansett Registered Voter count regardless of if you own a BSFD home/land or a BSBC Unit.
2. If you are not a registered Narragansett Voter but own a home or land in BSFD, you appear in the BSFD Property Owner count regardless if you own a beach club unit.
3. If you only own a beach club unit, you appear in the BSBC Owner count.
